We hope this newsletter finds you in good health and spirits as we welcome the Spring season. Spring is a time of renewal, growth, and hope, and we want to share some of the latest news and updates from REFCO that may interest you.

The FCERA Board of Retirement approved a cost-of-living-adjustment of 3% for 2024. The COLA will go into effect on April 1st. FCERA retirees and beneficiaries can expect to see that change on their April 30th pension payment.

Our REFCO board elections were held at the February luncheon/ annual meeting. I would like to welcome our newest board member Dawn Gallegos. Dawn retired from the Department of Social Services and has been serving as the Chair of the Sunshine Committee for the board.

During the annual meeting, under new business, I let attendees know that due to increased costs, the board is proposing an increase in member dues from \$1 a month to \$2 a month. The proposed increase would not take effect until 2025.

I hope you have a wonderful Spring and stay safe and healthy. As always, we are here to serve you and answer any questions you may have. Please feel free to contact us anytime or visit our website for more resources and updates.

Retirement Board Approves A 3% Cost of Living Increase

At its regular board meeting February 1, 2023, the Fresno County Employees' Retirement Association Board of Retirement approved a 3% cost of living increase for retirees and beneficiaries in all tiers except tiers 4 and 5. This change is effective April 1, 2023. This action was taken in accordance with Government Code section 31870.1 and, for 2022, the average annual change in the Consumer Price index for the West Region was 8.01 %, rounded to 8% (the nearest ½%). Because the maximum COLA that can be granted in a given year is 3.0%, the remaining 5% was rolled into a "COLA Bank" for years when the calculated COLA is below 3%.

Retirees who retired on or after April 2, 2022 and on or before April 1, 2023 now have a COLA Bank of 5%. Retirees who retired on or after April 2, 1982 and on or before April 1, 2021 now have a COLA Bank of 6.5% (1981 is 14.5%, 1980 is 26.5%, and 1979 32.0%.)

Valley Animal Center houses thousands of dogs and cats annually until they are placed in loving homes. Most of their shelter animals are rescued from local animal control agencies who have no more space for their animals. Even animals who have been abused, mistreated, abandoned, or injured are cared for and nurtured until a loving home is ready to adopt them.

Valley Animal Center is a community-supported organization. Financial support is derived solely through donations from the community, grants, program services, and fundraising efforts. Their mission is to unite dogs and cats with loving people.

The donated items needed are liquid laundry detergent, bleach and dish soap (Dawn). Also needed are blankets and wet cat and wet dog food. Monetary donations are always accepted at the REFCO luncheon.






